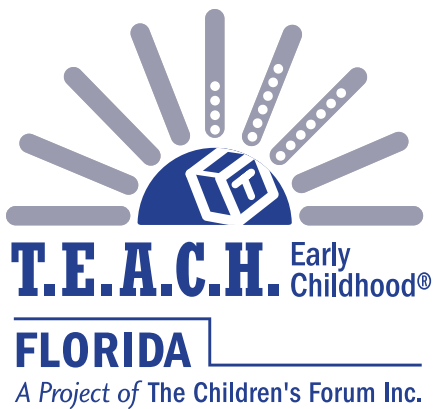

T.E.A.C.H. Early Childhood® Scholarship Program

Action Requested: Support the legislative budget request of an additional \$1.5M submitted by Governor Scott and the Office of Early Learning to provide scholarships for child care and early learning practitioners through the T.E.A.C.H. Early Childhood® Scholarship Program for a total of \$4.5M. The full appropriation will fund approximately 4,000 – 4,500 total scholarships in 2015-16.

Issue: Brain research makes it clear that early experiences are critical for successful brain development, and making sure these quality early experiences are possible is far more effective than trying to address problems at a later age. It takes a qualified, educated, stable and effective teacher to provide the types of experiences that are needed to build trust and promote learning. Children, particularly those from low-income, vulnerable families, who receive quality early care and education, are more likely to be readers by third grade, graduate high school, pursue secondary education and go on to be contributing members of society. Unfortunately, many of those working in VPK and early learning programs throughout Florida do not have the requisite education and training to ensure that children receive the maximum benefit from their experiences, a fact exacerbated by low wages and high staff turnover. The T.E.A.C.H. program successfully addresses these three key issues (**teacher education, turnover, and compensation**) to improve the outcomes for Florida's children. To increase the supply of well-prepared teachers, an increase in funding is needed to serve practitioners who are eligible and awaiting scholarships.

Background: The T.E.A.C.H. program (F.S. Chapter 1002.95), first received statewide funding in 1998 to assist child care and early learning practitioners and has provided scholarships for over 21,778 recipients since that time. **The program has been level funded for the past 13 years at \$3M annually. Costs since 2002 have increased by approximately 24% which means that fewer dollars are available to serve students.** The Program consistently produces data-driven, measurable outcomes that address the challenges of the field (**teacher education, turnover, and compensation**) and provides access to a well-trained and qualified counselor through the T.E.A.C.H. office to help recipients navigate the often confusing landscape of professional development and higher education options.

How T.E.A.C.H. Works: The T.E.A.C.H. (Teacher Education and Compensation Helps) Early Childhood® Scholarship Program is a successful three-way partnership between the employer, the teacher and the T.E.A.C.H. program addressing the problems of **teacher education, turnover, and compensation** in the child care and early learning field. The employer agrees to pay a portion of the costs for tuition and books and provides paid release time weekly for the teacher to handle duties such as attending classes and completing homework assignments. The employer also agrees to provide at least a 2% raise or bonus at the end of a successful contract. The T.E.A.C.H. recipient agrees to pay a portion of the tuition and books, and agrees to remain employed at their sponsoring center for one year beyond the end of the contract. The T.E.A.C.H. program agrees to pay a majority of the costs and provides a bonus upon successful completion. The T.E.A.C.H. program, created and licensed by the Child Care Services Association in North Carolina, operates in 24 states and the District of Columbia. The Children's Forum in Tallahassee, FL holds the license to administer the T.E.A.C.H. program in Florida.
